

**CHILDREN'S SNOW SPORTS SCHOOL
FULL AND COMPLETE RELEASE OF LIABILITY AND INDEMNITY AGREEMENT**

The undersigned, being at least 18 years of age, hereby represents that he or she is the parent or guardian of _____ (hereinafter referred to as the "child") and, in exchange for Santa Fe Ski Company/Sandia Peak Ski Company (hereinafter referred to as Ski Company) making these services available to me and the child, hereby contracts and agrees as follows.

For myself and for the child, I, the undersigned parent or guardian, agree and understand that skiing is a **HAZARDOUS ACTIVITY** which may result in **INJURY or DEATH** to my child **DURING** his/her participation in Santa Fe Snow Sports School/Sandia Peak Snow Sports School (hereinafter referred to as Snow Sports School). I also understand that my child will be using **SKI LIFTS WITHOUT A SNOW SPORTS SCHOOL INSTRUCTOR OR OTHER ADULT PRESENT**, and that my child, on a completely voluntary basis may decide to use the **RACE COURSE** and/or **TERRAIN PARK**, which **INCREASES RISK**. Trail conditions vary constantly because of weather changes and skier use and even the best equipment and instruction cannot prevent injury. Natural and manmade obstacles, including other skiers, exist and collisions do occur. **PARTICIPATION IN CHILDREN'S SNOW SPORTS SCHOOL SHALL NOT IN ANY WAY ELIMINATE THE INHERENT RISKS IN SNOW SKIING OR RIDING SKI LIFTS**. I hereby **ASSUME ALL RISKS** in connection with my child's participation in skiing, ski school classes and all related activities ("Activities") including but not limited to personal injury and death, and **HEREBY COMPLETELY RELEASE** Ski Company, and the US Forest Service, their representatives, agents, affiliates, officers, directors, servants, and employees (jointly and individually "Released Party") from **ALL LIABILITY** for any injuries, death or damages and from any claim or legal action by me, any other parent or guardian of the child, the child, anyone on behalf of the child, and by the child's estate, heirs and assigns arising in any way from my child's participation in the Activities, including any claim based on **NEGLIGENCE, VIOLATION OF ANY STATUTE OR BREACH OF CONTRACT** by any Released Party.

In addition, I represent to Ski Company that I have the authority to enter into this contract on behalf of said **MINOR** and on behalf of any other parent or guardian of said **MINOR** and **AGREE TO DEFEND AND INDEMNIFY** and hold harmless Ski Company from any and all claims arising from the child's participation in the Activities and this contract, brought on behalf of said **MINOR** or any parent/guardian thereof, even after the **MINOR** has attained majority, or from third parties injured by the **MINOR**, and hold each Released Party harmless from any such claim, legal action, harm, injury, damages or loss to person and/or property, including but not limited to paying their attorney fees and costs.

I further **AUTHORIZE** anyone working at the Ski Company to call for such medical care for the child or to transport the child to the appropriate clinic or hospital if, in the opinion of anyone working at the Ski Company, medical attention is needed for the child. The undersigned agrees that upon turning the child over to me or my designees or to any ambulance or other medical transport, medical facility, clinic or hospital that the responsibility of Ski Company shall be totally fulfilled and Ski Company shall not have any further responsibility for the child. I **AGREE TO PAY** all costs associated with such medical care and related transportation for the child and **INDEMNIFY** and hold each Released Party, its representatives, agents, affiliates, directors, servants and employees harmless from any costs incurred therein, or any claims arising therefrom.

In exchange for, and in consideration of, each Released Party making these classes and the ski area available to the child for participation in the Activities, I **CONTRACTUALLY AGREE** that any and all disputes between myself and/or any **MINOR** and any Released Party arising from the child's participation in the Activities or the child's participation in the sport of skiing, and including any claims for personal injury and/or death, will be **GOVERNED BY THE LAWS OF THE STATE OF NEW MEXICO** and the **EXCLUSIVE JURISDICTION** thereof will be in the state or federal courts of the **STATE OF NEW MEXICO**.

Ski Company **STRONGLY SUGGESTS** that I obtain or confirm the existence of **HEALTH** and/or **ACCIDENT and LIFE INSURANCE** to protect me and each **MINOR PARTICIPANT** **BEORE PARTICIPATION** in the Activities or **NOT PARTICIPATE UNTIL IT IS OBTAINED**.

I have carefully read the foregoing **FULL AND COMPLETE RELEASE OF LIABILITY AND INDEMNITY AGREEMENT** and understand its contents, including the jurisdictional agreement. I **ACKNOWLEDGE** and understand this is a **FULL AND COMPLETE RELEASE OF LIABILITY AND INDEMNITY AGREEMENT** ("Agreement"), that it includes **any and all claims by the child, me** or anyone else on the child's behalf for any reason, **INCLUDING NEGLIGENCE, or BREACH OF ANY STATUTE OR CONTRACT** and that I am contractually agreeing to these terms **FREELY, FULLY AND WITHOUT RESERVATION** in exchange for the right to have the child participate in the Activities at this ski area. **IF I CHOOSE TO USE A VOUCHER FROM THIS AGREEMENT TO OBTAIN ANY PASSHOLDER PLATINUM, GOLD, MILLENNIUM, SILVER, BRONZE, FREEDOM, SNOWSPORTS PASSPORT OR PEAK PLUS CARD I AGREE THIS AGREEMENT WILL APPLY TO ANY SUCH PASS/CARD WITHOUT MY HAVING TO SIGN A FURTHER AGREEMENT AND WILL APPLY EACH TIME OF USE DURING THE ENTIRE SKI SEASON**

If any part of this Agreement is deemed unenforceable, the remainder shall be an enforceable contract between the parties. **I AM AWARE THAT THIS CONTRACT IS LEGALLY BINDING AND THAT I AM RELEASING LEGAL RIGHTS OF ME AND ANY MINOR BY SIGNING IT.**
